AS A SUPPORTING ORGANIZATION TO BEYOND HOUSING, INC., THE 24:1 COMMUNITY LAND TRUST (CLT) WORKS IN PARTNERSHIP WITH BEYOND HOUSING TO SUPPORT THEIR HOUSING AND ECONOMIC DEVELOPMENT PROGRAMS. SINCE 2012, THE CLT HAS FINANCED THE CONSTRUCTION OF 10 NEW HOMES IN PINE LAWN, MO ALONG WITH THE PURCHASE AND REHABILITATION OF 13 HOMES IN NORTHWOODS, HANLEY HILLS, AND NORMANDY. AT THE END OF 2014, 18 OF THESE HOMES HAD BEEN SOLD TO LOW INCOME HOUSEHOLDS WITH FINANCING FROM THE LAND TRUST. THE REMAINDER HAVE BEEN COMPLETED FOR FUTURE SALE. THE CLT HAS ALSO ESTABLISHED A CONSTRUCTION/DEMOLITION COMPANY TO DEMOLISH STRUCTURES ON SCATTERED PROPERTIES ACQUIRED BY THE LAND TRUST, THUS PREPARING THE LAND FOR FUTURE DEVELOPMENT.
