AS A SUPPORTING ORGANIZATION TO BEYOND HOUSING, INC., THE 24:1 COMMUNITY LAND TRUST (CLT) WORKS IN PARTNERSHIP WITH BEYOND HOUSING TO SUPPORT THEIR HOUSING AND ECONOMIC DEVELOPMENT PROGRAMS. SINCE 2012, THE CLT HAS FINANCED THE CONSTRUCTION OF 10 NEW HOMES IN PINE LAWN, MO ALONG WITH THE PURCHASE AND REHABILITATION OF 20 HOMES IN THE NORMANDY SCHOOL DISTRICT GEOGRAPHY. THESE HOMES HAVE BEEN SOLD TO LOW INCOME HOUSEHOLDS WITH FINANCING FROM THE LAND TRUST. THE REMAINDER HAVE BEEN COMPLETED FOR FUTURE SALE.

THE CLT ALSO ESTABLISHED A CONSTRUCTION COMPANY IN 2014. ITS MAIN PURPOSE SINCE INCEPTION HAS BEEN TO DEMOLISH CLT OWNED COMMERCIAL AND RESIDENTIAL PROPERTIES IN PAGEDALE, PINE LAWN, HILLSDALE AND
